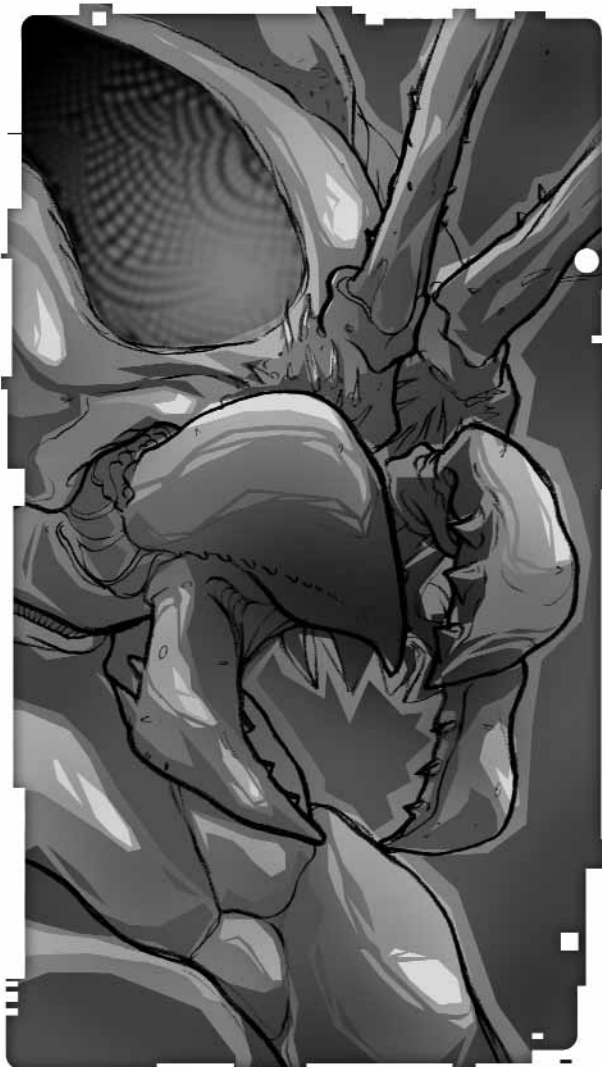




MECHITE
