LORD PROTECTOR VICTORY

VICTORY FOR THE LORD PROTECTOR Denhaven, Central Elkia

News has reached the hallowed halls of the Ormocean Temple that our forces in Denhaven have won a great victory against the Sardian forces attacking the city. Reports indicate that the Sardian legions have suffered a major defeat and that the siege of Denhaven has been lifted. All praise Ormocea!

For the past three spans the Sardian army has been encamped outside our fair capitol, preparing siege engines and consolidating their position. The command of the forces arranged against Denhaven had been given to General Marding, of the Legion Red Dragon. Marding, formerly a Trezkillian Invigilator attached to the Red Dragon, received a meteoric rise to the rank of General after he took command of the legion during the Battle of Hillowglade Field. Marding was awarded the "Silver Serpent" for his actions during the battle and that the medal was presented by the Lord Chancellor Kharichaan in person, adding to recent rumours that the Lord Chancellor of Sard has been secretly visiting his troops at the front and overseeing the siege of Denhaven.

Reports from Denhaven describe that, as of the 1st Day of Life, the Sardian army had completed its encirclement of the capitol, with the Legions of the Red Dragon, the Sundered Skull and the Black Widow having taken up positions to its north and east. The Legions of the Grey Wolf and elements of the Burning Sword were positioned in the hills directly south of the city as a defensive move against any threat from the Elkian 10th Heavy Foot, which has reportedly been advancing north through mountain passes in the Splintrock Heights.

Elkian positions there came under intensive bombardment from Sardian catapults for over an hour before the sappers of the Red Dragon moved three enormous siege towers into the field, supported by a force of 1,000 men. The brave Elkian defenders rained arrows down upon the Sardians and one of the siege towers was destroyed by fire early on in the engagement. By 3ASR the fight for the Hallenheart Tower was well underway and the Lord Protector was diverting defenders from other parts of Denhaven to the melee. General Marding chose this time to launch a number of smaller assaults on the eastern walls of the city and a major attack on the Sword Gate, the major entryway into Denhaven. A great ram was brought to bear against the gates while companies of Maritaani mercenary archers pinned down the defenders.

By 6ASR things looked grim for our brothers and sisters in Denhaven. The lower levels of the Hallenheart had been seized by the enemy and fierce fighting was occurring along the western walls and in the streets below. In the east, the great ram had been stopped in its tracks after one of its wheels became bogged in the ground, however soldiers of the Black Widow attacked the walls with scaling ladders and managed to gain a foothold, threatening to take the Sword Gate from within.

But the faith in the Holy Trinity by the people of Elkia remained resolute and they redoubled their efforts to drive the Sardians from their walls. By 7ASR, the Hallenheart had been retaken and the Red Dragon had been forced back to take up a defensive position on the north-west ramparts. At the Sword gate the fighting became very bloody with Justynn Vannad, Knight Commander of the Protectors of the Faith, leading a heroic defence of the gates with a small band of loyal paladins. Alas, Vannad was slain during the encounter but the Sardian dead about the Sword Gate were numbered in the hundreds. The gates were finally taken by the enemy and opened.

had penetrated the city attempted to flee the carnage in Draelingus Square, great confusion broke out amongst their ranks and the Elkian forces took advantage of the situation and inflicted devastating losses on them.

The Lord Protector chose this moment to sound his battle horns and unfurl the Holy Banner of the Paladin Saviour from the top of the Hallenheart Tower. The sight of this most ancient and hallowed relic further instilled morale and purpose into the weary Elkian forces and they rallied against the enemy. The effect upon the Sardians was the opposite; they quailed before the power of the Holy Banner and withdrew from the city, regrouping to take up a defensive position some 2 miles from Denhaven. Lord Farradain ordered his captains to harry the Sardians retreat but called his forces back to the safety of the city soon after. The 10th Heavy Foot marched triumphantly into Denhaven to bolster the strength of its forces.

The Gods are with us and we look forward to seeing the Lord Protector consolidate his position and begin a campaign to drive the Sardians from our tranquil lands and back to Gablehead. Remember this day – the Gods have shown you their strength. But only through your loyalty and steadfast faith and obedience in the Trinity can we command their protection. Listen not to deceivers, opportunists and Gnomes for they seek to spread their dark lies and therefore support the enemy!

During the afternoon of the 1st, a Trezkillian Invigilator entered Denhaven under a flag of truce, to negotiate the terms of the surrender of the city but the audience with Lord Protector Farradain lasted only an hour before the Invigilator was unceremoniously expelled from the city gates. PREVIOUS RESTRICTIONS

Reporting

Any strange occurrences are to be reported immediately to the **Shadow Task Force** which has a clearly marked booth in the Darringmoor Holy Markets. In particular, people acting peculiarly, suspicious barrels, and strange lights. Further investigations of this information will be followed up by the newly formed Shadow Task Force office in the Holy Market Compound. Failure to report will be an admission of guilt and those accused will face the **Court of Shadows**.

Missing people are to be continued to be reported to the Missing Persons section of the city guards as previously. Failure to do so will be an admission of guilt and those accused will face the **Court of Shadows**.

Time and date of flashes of Esmian Wedding Jars must be recorded and immediately taken to the Shadow Task Force. Failure to do so will be an admission of guilt and those accused will face the Court of Shadows.

Controlled Items

Embalming chemicals are now controlled items. Any sale of such has to be reported. Failure to do so will be an admission of guilt and those accused will face a Court of Shadows. The Shadow Task

Inquiry into the Lightbringers Commences 10th Day of Life

The Ormocean Church will be conducting an audit of the Lightbringers, the Order of the church that monitors the activities of the Keenings and ensures that the wards of the undercity remain intact. The audit will focus on the activities of the Lightbringers over the past 200 years, with a focus on identifying regional Keenings that may have not been properly investigated and maintained during that period. Three senior clerics will head the investigation and it is expected that over twenty operatives of the Lightbringers will be interviewed over a period of three spans. It is intended that a report will be provided to Saint Farwick by the end of the March of Life.

Force will be visiting those business dependent on these chemicals to record and track their use.

Restricted Areas

The Darringmoor Cemetery is out of bounds except for sanctioned burials and will be screened by a specialist team of the **Shadow Task Force** in the coming days. Failure to stay out of such restricted areas will be an admission of guilt and those accused will face a **Court of Shadows**. Anyone caught underground without authorization will immediately face prosecution by the **Court of Shadows**.

NEW RESTRICTIONS

Travel and Movement

Travellers moving in and out of the city (citizens or other) will be screened at both ports and city gates. For those whose travel is essential for business, you may, upon approval, be given travel passes, but must carry these at all times on their person and submit to regular screening. Allow extra time when travelling. Anyone failing to adhere to these restrictions will immediately face prosecution by the **Court of Shadows**.

Sedition

Deliberate undermining of lawful authorties through sabotage of new Shadow Court policy or of its members by negative verbal or physical actions will face prosecution by the **Court of Shadows**.

Controlled Items

Total ban on possession of amber and mysteria oil. They are controlled substances and must be handed in as soon as possible. Any sale of such must to be reported. Failure to do so will be an admission of guilt and those accused will face a **Court of Shadows**.

Farwick's Counter-Undead Plan

Be Ever Vigilant

Undead pose a direct and ongoing threat to the safety and wellbeing of Darringmoor citizens and populous of the surrounding area in Sard, Elkia and Llan. The current Undead threat is unprecedented in recent. Farwick's Counter-Undead Plan outlines the arrangements, governance and operational responsibilities of all Darringmoor citizens, governments and agencies engaged in countering the Undead threat.

Strategy for Protecting Crowded Places from Terrorism

Crowded places such as markets, docks, and major events will continue to be attractive targets for undead attacks. Darringmoor is not immune after Blacklight Day. The objective of **Farwick's Counter Undead Plan** is to protect the lives of people working in, using, and visiting crowded places by making these places more resilient to attacks by Sirrith's Minions.

Compensation

In the March of Air the Darringmoor Ormocean Church will provide financial assistance to people affected by Blacklight Day. The Darringmoor Victim of Undead Payment (DVUP) will be a one-off payment of up to one gold trade and will provide financial assistance for Darringmoor residents who are harmed as a direct result of defending the city from the undead incursion. Payment may be shared among eligible close family members of someone that died as a direct result of this undead incursion. Proof of defence is required for payment. Contact the Ormocean Church if you meet the requirements.

Know Your Enemy

For an effective counter-undead regime, it is vital that laws target not only undead acts, but also the organisations that plan, finance and carry out such acts. Under Ormocean Law, amendment R5437, there are two ways for an organisation to be identified as an undead organisation. Reasonable doubt has been proven that an organisation is a undead organisation offence. Alternatively, the organisation may be specified in Regulations as an undead organisation. This process, known as 'listing'. For more information on the process

•Laws to Combat Undead—The Ormocean church has a very extensive range of legislation around counter-undead, national security and related offences.

• Undead Task Force—is made up of representatives from the Holy Trinity, Darringmoor Council, Major and guild leaders. This force's goal is to strengthen cooperation, collaboration and build capability to counter undead incursions.

•Declared Area Offence—information about the offence of entering, or remaining in, a declared area where a listed undead organisation is engaging in a hostile activity.

Additional prohibitions:

Prohibited - Reading of the Little Dart. **Prohibited** - Being in possession of said Little Dart.

Absent Animals

143 Small Animals have been reported strangely missing in Darringmoor City. A local residents group of Clifftown has confirmed household pets and animals have disappeared. Boonick V'Reel, a resident recounted that for over one march small animals have been missing and the numbers are increasing.

Small cats, dogs, piglets and chickens no more than two foot from snout to tail have been reported missing The numbers have been increasing since the March of Fire. The count so far is about 143 but there may be many unreported cases. Another local, Mistress Enydolk said that she can't remember a season where she had never seen a rat, mouse or cliff possum climbing the cliffs at night.
