# Marseilles BlackEagle Cell Wiped Out.

#### Marseilles BlackEagle Cell Wiped Out. By Hal Dent, (Ops, Marseilles)

In a textbook attack on one of our clients two weeks ago, cell two, our close protection specialists, comprising Marc Dijon, Louis Carnier, Jacques Ferne, and Carl Schwartz, was completely destroyed, along with our client, Horst Liebermilch.

Currently, it is not known for certain who performed the attack, and the French Authorities are keeping at it. It is known that the weapons used were of modern military origin, and that the tactics used were of military derivation, including 40mm grenades, 7.62mm and 5.56mm assault weaponry and smoke grenades. More that this, we don't know, as eye-witnesses have been few and far between.

We're reeling from this, but trying to carry on as best we can.

# Marseilles Regional Roundup By Jean Louis Tessier, (SCL, Marseilles)

Our employment position at the moment, is not helped by our recent losses, Cell 2, was entirely wiped out during a standard personal protection operation two weeks ago. Anyone who knew Cell 2 will greatly miss their cheerful manner in the office, their funerals will be held next week, and all are welcome. Tributes from BlackEagle offices around the world were commendable, and we thank you. Investigations are still continuing, with the French Surete supporting us in finding the motives for the attack on the client, in the South of France. A motor convoy of 4 cars, two of which were carrying members of Cell 2, were ambushed in a small town not far from Marseilles, one was taken out by a 40mm HE grenade, and the second was eliminated while evading the ambushing team along a hill road, with what appears to have been an anti-tank missile, and a large amount of overkill. The client was killed in Marseilles, along with the remaining personal protection officers from another local security agency. Insiders from French intelligence tell us that among other suspects in this almost terrorist act include the IRA, and some Russian group, possibly the Mafia. The target was a collection of intel reports held by the client, destined for Western intelligence groups. If any BlackEagle personnel have any information on activities by these groups, could they please pass it on ASAP.

Our remaining cells are now stepping up security, around the office and elsewhere, all Cells are now undergoing more extensive personal defence and evasion training, and we are reviewing our policy on carrying personal arms when on non-official business, we have local support from French Police, who welcome the additional qualified personnel in the vicinity.

As said in our summary of the work Marseilles office handle in the Mediterranean and the South of France, this area is becoming a haven for organised crime, usually the higher level members living up their spoils in this Eden of Europe. Local police are under-funded and under-manned, with several recent incidents requiring BlackEagle on call Cells to assist in armed sieges, and so far one bank robbery, in which the Cell concerned came under heavy fire, while some of the local Gendarmerie turned tail. The S.W.A.T teams are under increased pressure, some being used on patrol in Marseilles seedier districts, which are becoming reminiscent of central Miami before the Red zone was recognised. All in all, Marseilles is becoming a more lawless capital to the Côte d'crime.

So far, from the replies to our advertisement, we have enough personnel on their way to supply at least a Cell and a half, thank you all for your support, and we hope to be bringing you news for a long time to come.

# Notes from The Street

Editor's Note: James DiFalco (Ops, London), actually got his contribution in **right on the** deadline, so we can't really embarrass him this time, more's the pity. Of course, he does such a wonderful job himself, so with that, I'll let him put his feet (both of them) firmly in his mouth!

Ever wondered what happens when you're 'nicked' (translation for my international colleagues - arrested) in the good old UK??

Well if your answer to that is yes, please read on, and I'll tell you all about it - from first hand experience.

Our cell had just finished a small operation in a town in Essex, England called Harlow. A large pharmaceutical firm there had asked us to deal with an animal liberation group that they had heard was about to give them problems. As is tradition in our cell, to mark the successful end of the assignment, we went for a good old beer up, which we decided to do in Harlow (ed in Essex, and home of the term 'Lager Lout' in the UK).

Anyway, without going into to much detail, there was a small disagreement between our group and some local Neanderthals, which culminated in a small disagreement outside of a club we had been drinking in, where I was forced to put Ugg (I think that was his name) down (and for my exspecial forces colleagues that means unconscious, not double-tapped).

Seconds later, the towns' entire contingent of constabulary was there, blues and twos going (UK slang for the sirens sounding and blue lights flashing - ed), helicopter flying over head (okay, I exaggerate) - all very exciting stuff.

I found myself thrown to the ground with four plods (UK slang for Police officers - ed) sitting on me and the cuffs going on, so, being a good boy, I did not resist arrest.

I was lifted up and marched to a nearby police car, which delivered me to the local police station (which is a mere 400 yards away), where I was steered towards the custody area.

This particular custody area is accessed through an 'airlock' type system, we go through a heavy steel door into a small corridor, with another heavy steel door at the end, the second steel door does not open until the first is shut.

On entering the custody area I was steered towards the custody sergeant, who stood behind a raised desk, computer terminal to one side. One of the arresting officers stood to one side of the desk and explained what had happened, and why I was there. 'Seen by CCTV to hit another male, who has been conveyed to hospital' (oops) 'We arrested this gentleman under section 3 of the public order act' (rough translation - hitting someone in public), 'may go for ABH' (actual bodily harm) 'depending on what state the other male is in.'

The sergeant turned to me, and explained that he was happy with the circumstances of my arrest (I wasn't, unsurprisingly), and that he would authorise my detention whilst enquiries etc, etc, were made.

The cuffs were removed (thankfully, because those quick cuffs hurt - especially when the friendly officer forgets to lock the self tightening mechanism), I was searched and various details were taken (name, DOB, address, have I ever tried to take my own life etc.) and fed into the terminal (this is where I kept my fingers crossed, and hoped like hell that that my fake IDs were up to scratch). I was then informed of my right to a phone call and a solicitor (Ed - US: Lawyer) and the right to have a copy of the police code of conduct. I signed a few forms to say I understood what was going on, and the sergeant was happy (doesn't take much, really, does it?).

After the preliminary bits, I was told that I'd have to see the police doctor as (a) I'd been in a fight and (b) I'd been drinking (this man should be a detective). While I waited for the doctor, I was taken to my cell (my property stored elsewhere), a nice little room with a wooden bench and a stainless steel toilet (no toilet paper - O!!).

I'd just start to drift off to sleep, despite my neighbour banging on his cell door with his head (bless him) when my cell door was opened, and a civilian detention officer showed me to the FME's (Forensic Medical Examiner, or Doctor) room. The doctor asked me a set of routine questions filling in another form - was I in good health before coming here, do I take drugs, how much have I drunk etc. After our cosy little chat the doctor tells the civilian employee (called 'matron' by his uniformed colleagues) that I'd be fit for interview in a couple of hours (I hadn't drunk that much), and I was taken back to my cell, issued a PVC coated mattress and a blanket, and was finally allowed to go to sleep.

06:30 in the morning I was woken up by a different PC who took me off to be interviewed. He was kind enough to explain what was going on, and to give me a cup of tea - giving my brain a chance to get in gear. The interview was taped, and consisted of numerous questions (open ones to get me talking, had I been in the mood) that were intended to get me to admit to the required points, that would support the charge of a section 3 public order offence. Having been shown a copy of the CCTV footage I told the truth - yep, I hit him, but no, he started it.

The officer appeared satisfied with the interview, completed a few more forms, getting me to sign a number of them and showed me back to the custody area.

After a few minutes he and the custody sergeant appeared (different sergeant as the shift changed at 06:00) and I was stood before the desk once again. I was cautioned again (actually for the first time, since the arresting officers forgot to caution me in their excitement) and was told that I was to be charged under section 3 of the public order act, and that I was duty bound to appear at the local magistrates the following Tuesday - failure to do so could lead to this that and the other (mostly involving warrants, probably 3 a.m. knocks, and a lot of aggro).

After this I was photographed, finger printed and DNA sampled. The forms I signed (yes even more forms) said, in typically British legalistic jargon, that it was okay for these to be taken, and that I had the right to apply for the destruction of my finger print image should I be found not guilty.

I then got my property back, after signing another form and shown out of the station.

I'm free!!! Until Tuesday....

Right, that's a little overview as to what you can expect if you're arrested. Remember that it'll differ slightly from station to station and from county to county, but not by to much.

Maybe my next contribution to the bulletin will be on time, but it depends on the British Judicial system really doesn't it!?

Ed: Firstly, we don't recommend that you use fake identification papers with the Police - it can lead to all manner of complications - none of them pleasant, if they fail examination. Let's hope (if only for Bulletin content) that he gets a fine, or at worst a conditional discharge, then!

#### News from L&P... by Todd Bell, L&P, Atlanta

Greetings from L&P!

With the rapid advancements in digital photography, we at L&P have seen a marked decrease in the requests for photo developing as operatives switch over to faster and more secure digital photography. To this end we are eliminating photo developing as a service of the L&P field offices. The regional L&P centres in Atlanta and London will continue to offer developing and with overnight mail turn around time should be less then 72 hours.

Obviously this service is only going to be of value for sensitive photos that cannot go through local developing. Maybe now is the time to take a look at our selection of digital cameras?

There has been many requests for the M4 SPOMOD kit as used by US (and other) Special Operations. Well, we at L&P have gone one step farther. The base component of the kit is the Knight Modular Weapons System. Not only are we stocking it for the M4, but we also have versions for the M16, H&K MP5 (sorry, it won't fit SD models!), H&K HK53, H&K HK33/93, H&K G3/HK91 and H&K G36. All of the attachment components from the SOPMOD are available as individual items to make it easier to get exactly what you need. Check with your L&P rep for a price list and list of non-SOPMOD components that work with the MWS.

We have reached agreements with the relative US agencies to allow non-US based operatives to purchase Third Generation technology night vision devices (sorry, but 4<sup>th</sup> and 5<sup>th</sup> generation are still on the Military Technology Transfer Restriction list!). A small mountain of paperwork is still required to be filled out, but for a Litton Ranger M995 starlight scope it has to be worth it.

Unfortunately, still restricted to domestic sales is the Raytheon PalmIR 250 thermal imaging device. About the size of a good quality Hi8 camcorder and weighing 1.2 kilograms, the unit possesses 320x240 pixel resolution and a battery life of four hours on a 6V rechargeable battery. The unit features a focus range of 8 feet to infinity and an operational person detection range of up to 2,400 feet depending on weather and terrain. Options include alternate lenses, extra batteries, power cord adapter, and VCR adapter. Prices dictates this item be special order only so if you are interested give us a call and have \$12,495 ready.

We are now stocking Blade-Tech holsters. We have both Kydex and Concealex models available, but for the time being we are only stalking them for Glocks, SIG 226/228s and Colt 1911-pattern pistols. A wide range of pistols can be accommodated, but it will take at least two weeks to get it in from Washington.
